



TERMS & CONDITIONS

SELF CATERING HOLIDAY HOME ACCOMMODATION

The Canyons Lodge Self Catering Holiday Home fee allows for use all of the lodge facilities and grounds except for access to the second closet in the deluxe room, upstairs foyer storeroom, linen cupboard, kitchen pantry and shed, bar the need to enter shed to prime pump in the event of power failure.

1. A 20% non-refundable deposit of the accommodation fee is required within 14 days of placing the booking, or earlier in the event of another enquiry for the same period with the remainder of the fee payable 7 days prior to the booked date either by Visa/MasterCard, cash or direct credit.

2. Cancellation fees apply and include:
 - 1) \$100 administration fee if cancellation made more than 60 days prior to date of booking.
 - 2) 50% of full tariff if cancellation less than 30 days prior to date of booking.
 - 3) 100% of full tariff if cancellation less than 14 days prior to date of booking.
3. Credit card details are to be provided by the person responsible [Hirer] for booking for security of payment for any costs incurred incidentally or resulting from stay. Alternately a bond of \$1000 can be made payable to the above bank account.
4. Any loss, damage, breakage to lodge facilities/amenities and or requiring replacement, repair, service or otherwise that may occur during the period of stay will be charged against the credit card provided, or deducted from the bond. Charges for any of the above will be at the sole discretion of The Canyons Lodge management and will apply for 1 month after the departure date.
5. The number of occupants residing must not exceed the number specified when the booking was confirmed. If the number is exceeded an additional fee will be charged at the sole discretion of The Canyons Lodge management.
6. On departure the lodge is to be left clean and tidy and all rubbish placed in the appropriate wheelie bins. Should the lodge require cleaning in excess of normal requirements an additional charge of \$45 + GST per hour will be charged against the credit card provided. This fee will also apply for the disposal of excessive rubbish.

7. Checkout is to be no later than 10am unless by prior arrangement. Failure to vacate at the correct time may result in a full day's tariff being charged.
8. Noise control bylaws exist and must be adhered to at all times.
9. Stiletto heels are not to be worn inside the lodge at any time due to the likelihood of damage to the wooden floors, which are antique and irreplaceable, Reparation costs of \$250 per square meter will be charged for any fresh damage.
10. A gathering of more than 20 people is considered a function and will incur a minimum charge of \$500+ GST
11. A non- smoking environment exists throughout the interior of the lodge.
12. No animals are allowed.
13. The hirer is held responsible for all people staying at the lodge, including any 3rd party invitees.
